為何我們要求閣下填寫本表格? Why are we asking you to complete this form?

為維護稅制完整·全球各地政府現正推出適用於財務機構的資料收集及匯報新規定·名為共同匯報標準(簡稱『CRS』)。

To help protect the integrity of tax systems, governments around the world are introducing a new information-gathering and reporting requirement for financial institutions. This is known as the Common Reporting Standard ("the CRS").
